- Participants must ensure that all lights, animations and decorations are in place and activated for the judging period of Sunday, December 27 to Wednesday, December 30 between the hours of 6 pm and 9 pm.
- Contest winners will be announced on the Forward Janesville website, a special edition of our electronic newsletter and Facebook on January 4<sup>th</sup> at 1 pm. Winners do not need to be present to win. Winners notified via telephone or email.
