Purpose:

Contest Rules:

Participation is **FREE** and open to all residents and businesses within the Janesville city limits [**you must have a Janesville address**] and is open to the **first 35 registrants** on a first-come, first-served basis.

*Note: Previous winners in the 1st, 2nd & 3rd place categories of 2020 are not eligible for entry. **Honorable Mentions can enter.***

- Participants must submit a photo of their light display along with their registration.
- Participants agree to have one or more photos of their decorated residence or business exterior posted on the Forward Janesville website, newsletter, Facebook and printed publications, along with their last name and address.
- Participants agree there will be no compensation for postings or publications.
- Decorations must be visible from the curb/roadway. This includes all exterior and window decorations. Judges will not enter the property to view backyards or fenced side yards.
- All submissions are due **Friday, December 31** by midnight.
- Participants must ensure that all lights, animations and decorations are in place and activated for the judging period of Saturday, January 1 through January 6th between the hours of 5:30 pm and 9 pm.
- Contest winners will be notified via telephone or email on **Monday, January 11, 2022**. Winners will also be announced on the Forward Janesville Facebook page, a special edition of our electronic newsletter and on the Forward Janesville website.
